Bradley P. Barris, PhD./Circle K Achievement Award. All applicants must belong to a current Circle K organization. Total value of \$5,000.00: a maximum of \$1,250.00 per semester for four consecutive semesters. Once the applicant has received this award, he/she will be automatically awarded the next semester as long as the applicant continues meeting the required criteria (see below).

The application is 80% of the selection process. An interview, conducted with each applicant, is 20% of the selection process.

- This application MUST be completed on the GV Kiwanis website. NO HAND WRITEN APPLICATIONS.
- Applicant MUST meet all of the following points of criteria:
  - 1) Must be a paid Circle K member in good standing; currently enrolled as a 2<sup>nd</sup>, 3<sup>rd</sup> or 4<sup>th</sup> year student.
  - 2) Applicant's name must appear on both CKI District and International records for the current year.
  - 3) Applicant must be working towards a degree in one of the following fields of study:
    - Engineering Field (Mechanical, Electrical, Aerospace, Civil, Computer, Nuclear or Bio Medical)
    - Medical Field (Medical, Nursing, Pharmaceutical, Physical Therapy, Chemistry, Biology)
  - 4) Applicant must be a U.S. Citizen.
  - 5) Applicant must be a full-time student with a minimum of 12 credit hours per semester.
  - 6) Applicant must have a minimum GPA of 3.0. Attach a copy of your most recent unofficial transcript indicating GPA and number of credit hours completed.
  - 7) Attach a copy of the first page of your parent's last annual tax return (indicating total income and number of dependents in the home). Black out all SS numbers. If an applicant is independent (not dependent on parental assistance), he/she must include their own personal annual tax return from last year.
  - 8) Applicant must present a written explanation for why they should be selected for the Bradley P. Barris, PhD. Circle K Achievement Award. Include all financial or hardship information that will assist us when evaluating your application. Also include any plans you have for furthering your academic future.

#### **Required Qualifications for Continued College Financial Support**
